GENERAL GUIDELINES

1. All current members are eligible to enter three pieces of artwork, any media, in the exhibition. Memberships must be current through the end of the exhibit, expiring April 27th, 2012 or later. Artists may join or renew their membership at the time of drop off: February 27, 28 & 29, 2012, 9am-4pm.
2. 2-dimensional work must be framed, wired & ready for hanging (*no saw tooth hangers*)
3. GO ART! has some pedestals available for 3-D work. Please check with the GO ART! office (585-343-9313) if you have special display needs.
4. GO ART! reserves the right to accept or refuse pieces.
5. All questions should be directed to GO ART! 585-343-9313, or email info@GOart.org
6. **For press release purposes, it would be helpful if you could email or call us with the size and # of pieces (3 maximum) by February 17th, 2012. If work is to be created or is in progress, simply give us a general idea of size & medium. If you have an image(s) available digitally, that would be helpful to receive as well.**
7. The attached registration form should accompany your artwork when you drop it off.
8. All artwork should be labeled on the back with name, title, medium and price.
9. Work must remain at GO ART! for the entire duration of the exhibit.
10. Items may be offered for sale. If sold, GO ART! will receive 10% commission.
11. Insurance is the responsibility of the artist.
12. The artist is responsible for providing round-trip shipping, packaging, and postal insurance, if applicable.

- The First Annual Members Exhibition will be open to the public March 5 – April 27, 2012, 9am-4pm and by appointment.
 - The opening reception will be held Friday, March 16th 5-7pm.
 - Artwork Pick up: May 1 & 2, 9am-4pm
 - Artwork left at GO ART! after June 1st will become the property of GO ART!
